Chronic Fatigue Syndrome/Post Covid Syndrome Service Manager and Specialty Lead - 6 month secondment

Due to the Covid 19 pandemic, this service had established an assessment only service for Post Covid Syndrome (Long Covid) and I expanded this multidisciplinary service with 4 clinical appointments to provide treatments. With a backlog of patients, I developed a triaging system for the pending list, developed a new programme of symptom management to optimise therapy resources, engaged a sessional therapist to design and deliver these groups utilising their transferable skills from the Pain Management service. I transformed the workforce to offer traditional Occupational Therapy (OT) posts to Allied Health Professionals (AHPs)/Nurses to complement the existing OT staff, including service user representatives on all my interviews. A new NICE guideline had recently been published, therefore a revision to the entry referral criteria was required. Offered robust governance processes, support and training to a team that had experienced limited structure due to an absence of leadership.

I entered senior management following an extensive career in OT to develop transferable management and leadership skills. As a compassionate leader, I utilised my therapeutic skills with staffing groups, particularly two members of staff returning to work with complex life-changing health difficulties. I was also able to plan appropriate phased returns to work, with necessary reasonable adjustments to their job plans and the environment. I would always look to the holistic nature of the clinical pathways within these services, identifying any workforce transformations that would require AHPs. As OTs aim to enable individuals to reach their optimum level of function and well-being, I believe that as a manager, I was able to do this with my staff through supervision, appraisals, mentoring, coaching, and training skills.

Chronic Fatigue Syndrome/ME Service, Royal Cornwall Hospital Trust

NOV 2010 - MAY 2019

I managed a complex caseload of adults with CFS/ME and children with either CFS/ME or chronic fatigue associated with other health conditions, ranging from psychiatric disorders such as severe anxiety and eating disorders to cerebral palsy, brain tumours and respiratory conditions.

Delivered individual and group therapy using a biopsychosocial/ occupational approach to include fatigue management; lifestyle redesign; vocational rehabilitation; cognitive reframing; interventions to address relationships/sexual orientation/gender issues affected by their condition; pain management; psychological approaches; environmental assessments to address occupational barriers eg recommendations for ramps/wheelchair access; adaptive equipment and compensatory strategies to optimise independence; benefits/housing advice to ensure safe, secure accommodation and financed which impact on function; liaison with/onward referrals as appropriate to community services such as Psychiatry, Social Services, Voluntary agencies eg Shelter.

During this time, I co-founded a Royal College of Occupational Therapy (RCOT) locality group to offer peer support and sharing of good practice, then subsequently established the Cornwall Conference Committee as a sub group. I also trained as a voluntary Health and Well Being Champion with RCOT to advocate and taught work-based interventions to a variety of health professionals, including AHPs, medics, nurses and social care staff.

APR 2009 - OCT 2010

This was a fixed term secondment assessing the psychological experience of patients with a long-term condition (LTC), and I focused on Breast Cancer, Diabetes and Respiratory conditions. During the project I established relevant assessment tools, developed innovate methods to capture data and influenced health professionals within these services to start to consider the impact of anxiety and depression on the clinical pathway and patient recovery. Within respiratory services I contributed to the Pulmonary Rehabilitation Group to teach patients anxiety and depression management techniques, then went on to upskill the local OTs to continue these sessions. My concluding report on this project contributed to the development of community therapy services for respiratory patients in specific areas of the county, followed later with a large injection of capital to replicate the services in the whole of the county.

DEC 2004 - APR 2009

As the only OT across two teams, I offered direct therapy to individuals, case coordination of some people, as well as consultations to colleagues working with their patients experiencing severe mental health disorders. We ran specific groups for people with Personality Disorders, I contributed to the Dialectical Behaviour Therapy groups utilising sensory integration approaches for emotional regulation to facilitate occupation. The patients ranged from those experiencing anxiety and depression, to schizophrenia, with a severe catatonic patient for whom I managed a comprehensive care package and supported the consultant to deal with some very difficult safeguarding issues. I presented at Mental Health Act tribunals to advocate patient safety.
